 - (a) by promotion of a suitable person on the basis of selection from amongst the persons holding the post of Reader in Govrnment Dental Colleges or the post of Reader in Dentistry in a Government Medical College in the Service, possessing qualifications and experience mentioned in columns (3) and (4) against entry 3 of the Schedule; or
 - (b) by nomination from amongs: candidates who,-
 - (i) unless already in the service of Government are not more than 40 years of age; and
 - (ii) possess qualifications and experience mentioned in columns (3) and (4) against entry 3 of the Schedule.
- 6. Notwithstanding anything contained in rules 3, 4, and 5 the age limit prescribed in these rules may be relaxed by Government on the mommendation of the Commission in favour of a candidate having exceptial qualifications or experience or both.
